Dear Investor in Landmarc Capital Partners, LLC:

The Maricopa County Superior Court appointed the Superintendent of the Arizona Department of Financial Institutions as the Receiver of Landmarc Capital & Investment Company ("Landmarc"). As the Receiver of Landmarc, the Receiver serves as the manager of Landmarc Capital Partners, LLC ("Capital Partners") pursuant to the terms of the Operating Agreement of Capital Partners.

This letter and its attachment(s) comprise the October 2010 Loan/Property Status Report.

Attached as Exhibit "A" is a spreadsheet that provides a description of each of the loans or properties held by Capital Partners. Exhibit "A" should be read in concert with the documents that were sent to you in September 2009 (and each Report issued since that date) which included a spreadsheet of all Capital Partners loans/assets.

If you have misplaced any Report since that date, copies are located at the Receiver's website:

As of October 31, 2010, there were ninety (90) loans/assets being managed by the Receiver on behalf of Capital Partners. These ninety (90) loans/assets have a face value of \$51,726,904 of which \$27,373,838 is allocable to Capital Partners.

Three (3) of the loans with a partners' investment value of \$437,092 are current.

Two (2) of the loans with a partners' investment value of \$179,742 are in excess of 30 days past due.

Twenty-two (22) loans with a partners' investment value of \$8,778,042 are in some stage of the foreclosure process.

Three (3) loans with a partners' investment value of \$594,325 are in some stage of bankruptcy proceedings.

Eighteen (18) loans were transferred to an outside servicing agent, with a partners' investment value of \$3,847,320. Two (2) of the transferred loans are current. Eight (8) of the transferred loans have become delinquent and have been placed in foreclosure status. One (1) of the transferred loans has become REO.

As of October 31, 2010, there are Forty-eight (48) Capital Partners REO properties. Thirty-eight (38) of these properties are residential properties. Thirty-six are in active rental status, of which twenty-four (24) are rented. Four (4) of the Forty-eight (48) REO properties are listed for sale. Two (2) REO properties have received Court approval for sale.

In the month of October, \$40,407.14 was collected in mortgage payments. No rental income was received as repair expenses on vacated properties exceeded rent collected. Since the inception of the Receivership on June 24, 2009, the Receiver has collected \$1,571,025.94 for the benefit of Capital Partners. The Receivership has, through October, paid out \$227,270.31 in trust and other expenses for performing loans and distributed \$460,000 to investors. The cash balance held in the Capital Partners Trust account is \$883,755.63 at October 31, 2010.
